# Achieving Safety Ethics: Introducing the Code of Ethics for Safety and Health Practitioners

### Highlights of the seminar:

With the news of technical breaches in mega-projects, unabated safety-related incident trend, and the convictions of site safety personnel, it is timely to visit the issue of professional ethics in relation to safety. International studies have indicated that within the construction industry, unethical practices are major contributor to poor safety practices. Recognising this situation, in the proposed revision of the continuing professional development (CPD) programmes for safety officers and supervisors, Labour Department has required for the contents on professional ethics and integrity to be included in the training. The Institute of Safety and Health Practitioners (ISHP) has aligned with the Labour Department in this respect by rolling out a set of code of ethics for safety profession. In this seminar and representing ISHP, the speaker will delineate the basic principles of professional ethics and integrity, and competence that are enshrined in the Institute's Code of Ethics. The topics that will be covered include (but not limited to) means to maintain integrity, regulatory compliance, handling conflict of interest, and commitment to professionalism. It is hope that the contents of the seminar and the Code can provide general guideline for safety professionals in their daily activities in maintaining high professional and ethical standard, and satisfying the Labour Department's latest CPD requirement.

**Dr. Koh Tas Yong**; FISHP, MCIOB; PhD, MSc(Building), BBCM(Hons), DipBuilding

Dr. Koh Tas Yong is the Vice Chairman (Internal Affairs) of ISHP. He is also a Lecturer at the Department of Real Estate and Construction, the University of Hong Kong. Tas' research interests revolve around construction project team dynamics and construction project safety. He is currently growing his research platform on ageing workforce in construction industry. In addition to academic works, Tas is also active in industry engagement. Through these engagements, Tas has contributed to knowledge exchange by acting as a bridge between academia and industry through various industry-related activities, e.g., CPD seminar presentation and participating in industry working groups.
